

# BYLAW NO. 86-2025 UTILITY RATE BYLAW

# A BYLAW OF THE TOWN OF HEPBURN TO AMEND BYLAW NO. 81-2024 WHICH PROVIDES FOR THE FIXING OF WATER RATES, SEWER SERVICE CHARGES AND UTILITY INFRASTRUCTURE FEES.

COUNCIL of the Town of Hepburn, in the Province of Saskatchewan, enacts as follows:

- 1. That the Schedules attached and marked "A", "B", "C", and "D" shall take effect in all respects as Schedule A, B, C and D to bylaw 81-2024.
- 2. That Schedule A, B, C and D to bylaw 81-2024 enacted on January 17, 2024 be repealed.

The rates, charges, tolls or rents contained within this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.

Read a SECOND time this 21st day of May, 2025.

Read a THIRD time and adopted this 21st day of May, 2025.
