Without limiting the generality of the foregoing, the Town of Hepburn may consider any other factor besides price and capability to perform the work that it deems in its sole discretion to be relevant to its decision including but not limited to the following:

- 3. Proposed Menu (quality, uniqueness, price etc.)
- 4. The results of any reference check done by the Town of Hepburn; and

- The Tenderer will have exclusive use of all existing concession equipment owned by the Town of Hepburn which includes a grill, deep fryer, fridge, freezers, Bunn coffee maker, cappuccino and hot chocolate machine, hot plate, restaurant pagers, microwave, hotdog roller, cash register, crockpot, and nacho cheese warmer and will be responsible for cleaning and general upkeep of the equipment.
- The Tenderer shall maintain hours of operation to accommodate all recreational activities in the Hepburn Arena, including minor hockey games, senior hockey games, special events, figure skating carnival, tournaments, and additional events that may occur; and other hours outside the listed events will be at the discretion of the operator.
- The Tenderer shall be responsible for all personnel necessary to operate the concession in accordance with Public Health standards.
- The Tenderer is responsible for providing all inventory and supplies necessary for the operation of the concession.
