

## FAMILY RENTAL AGREEMENT / WAIVER

The Rental Agreement may be executed in any number of counterparts with the same effect as if all parties had signed the same document. All counterparts shall be construed together, and shall constitute one and the same Rental Agreement.

## **TERMS OF CONTRACT**

Special reduced rate of \$60 per hour

Payable at the town office or facility in advance of the event. Payments can be made via cash, cheque or etransfer. Make cheques payable to the Town of Hepburn, e-transfer to <u>onlinepayments@hepburn.ca</u>. If **paying by e-transfer, please enter "Arena Family Rental" in the message field.** 

## Site-Specific Terms and Conditions:

- 1. By booking the renter declares that all participants are members of one family unit and reside in the same household.
- 2. Food and/or beverages may not be brought into or consumed in the arena other than an individual water bottle.
- 3. Masks are to be worn at all times.
- 4. Rental of ice time is based on a "60" minute hour (ice surface floods, when deemed necessary, will be conducted between rentals).
- 5. The representative shall ensure that all members remain off the ice during the resurfacing and shall not enter the ice surface until the resurfacing has been completed and the resurfacer is off the ice.
- 6. Renters must clear the ice of puck(s), cones (ect.) and leave the ice surface promptly to help maintain the schedules.
- 7. The Town of Hepburn and employees will not be held responsible for loss or theft of articles in and on the arena facility property.
- 8. The representative renting the ice shall be responsible for all damages caused to the building, grounds, and equipment belonging to the Arena, reasonable wear and tear considered. The said damages are to be repaired or paid for to the full satisfaction of the management.
- 9. The representative renting the ice shall be responsible for such insurance as may be necessary for its personnel and shall assume full liability for any accident occurring in connection with the rental of ice. Proof of insurance may be required provided prior to use of the facility.
- 10. No smoking is allowed in the Arena Facility.
- 11. Consumption or possession of alcohol is not allowed on the premises of the facility, unless approved by town office and an Authorized Permit for such an event is secured and posted in accordance with the Saskatchewan Liquor & Gaming Authority.
- 12. The Hepburn Arena is a non-smoking and cannabis free facility.
- 13. The Renter must return a signed copy of this Rental Agreement to the Town at the time of booking. A facsimile or email copy of The Renter's signature shall be sufficient and binding.
