- Return all weights and equipment to their proper locations.
- Showers, change rooms, and washrooms are located in the gymnasium.
- The gymnasium may be available for walking/running when not booked for rentals (see posted schedule).
- Be respectful of others at all times.
- Report any damage or issues to the Town Office immediately.
- No food or alcohol permitted (water/sports drinks only).
- No smoking or vaping on the premises.
