Hydraulics and hydrostatic drive work. Augers work but shake.

Needs Servicing on the vertical and horizontal auger

- Condition mounts are worn
- Has propane leaks
- Wash water vacuum pump and tank not functional
- Springs on conditioner need replacing
- Brakes are not functional
- Gas leak

CONDITIONS – This Tender:

2. must be received by **2:00 P.M. on Thursday, July 14, 2022**

3. must be accompanied by a certified cheque, money order or bank draft representing five percent (5%) of the amount of the tender. Tenders submitted without certified funds will not be considered.

TERMS – That:

1. the highest, or any tender, not necessarily accepted.

2. the successful bidder will have 14 days to provide the balance of funds to complete the purchase. The deposit will be forfeited if the successful bidder does not finalize the agreement for sale within the required time.

3. all legal costs, title transfer fees, moving fees and applicable taxes are the responsibility of the purchaser and are in addition to the bid price.

4. the Purchaser agrees that Hepburn has made no agreement, representation or warranty of any kind as to the condition of the vehicle/equipment, or as to the fitness or suitability of such for the uses intended by the Purchaser, and that it has had an opportunity to inspect the vehicle/ equipment and has done so to its satisfaction or has waived its right thereto. The Purchaser will accept the vehicle/ equipment on an "as is, where is" basis on the Closing Date and shall indemnify and save harmless Hepburn, and its subsidiaries and affiliates, and their respective present and former shareholders, directors, officers, agents, servants, partners and employees, from any claims, liabilities, demands, injuries or expenses made by third parties in respect of the condition of the vehicle/ equipment.
